



INSTRUCTIONS FOR COMPLETION OF THE AFFIDAVIT OF HEIRSHIP FORM

The Affidavit of Heirship form should be:

- Completed if the decedent did not leave a Will or the Will is not being probated in the state where the property is located.
- Completed by a disinterested party who has adequate knowledge of the decedent and his/her family.
- Completed in full, with true and accurate information, to the best of his/her knowledge. Please attach a separate sheet, if additional space is needed.
- Witnessed, signed and notarized by a Notary Public.
- Filed and recorded in each county/parish/district/state in which property is located, including any separate pages used. The Laws of Descent and Distribution for the state in which the property is located will be followed.
- Return the original executed and notarized Affidavit of Heirship and death certificate for decedent to Crowheart Energy, LLC along with any other applicable documents to:

If any of the following is available, please include as it would be of great assistance in clarifying title to the mineral interest.

If there is a Will which **has been** probated, please enclose recorded copies of the following documents:

- Last Will and Testament
- Letters Testamentary
- Order Admitting Will to Probate
- Proof of Inheritance Tax paid, if applicable
- Final Decree or applicable document distributing Estate.

If there is a Will which **has not** been probated, please enclose copies of the following documents:

- Death Certificate
- Last Will and Testament

Provide copies of any other pertinent estate documents.

Definitions:

Decedent: Name of deceased person for whom the Affidavit of Heirship Form is being completed about.

Affiant: Name of person completing the Affidavit of Heirship Form

Corroborating Affiant: Person who confirms information provided on the affidavit form and is not an heir of the decedent.
